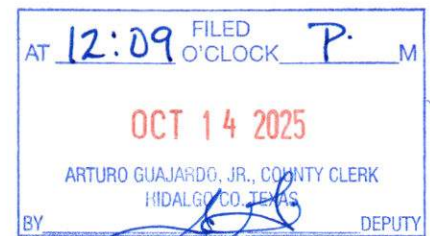


NOTICE OF A REGULAR MEETING HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 1
