CANVASSING RETURNS AND DECLARING RESULTS OF THE MAY 2, 2026 ELECTION ON THE PROPOSITION TO AUTHORIZE IN HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 1 A MAXIMUM AD VALOREM TAX RATE OF TEN (10¢) CENTS ON EACH \$100 OF TAXABLE VALUE OF PROPERTY AS PROVIDED UNDER HEALTH AND SAFETY CODE §775.0745.

Commissioner Ramon Montalvo introduced an Order and made a Motion that the same be adopted. Commissioner James A. Vos seconded the Motion for adoption of the Order. The Motion, carrying with it the adoption of the Order, prevailed by the following vote:

Commissioner Mark McCaleb thereupon announced that the Motion had duly and lawfully carried and that the Order had been duly and lawfully adopted.

The Order thus adopted reads as follows:

ORDER CANVASSING RETURNS AND DECLARING RESULTS OF THE MAY 2, 2026 ELECTION ON THE PROPOSITION TO AUTHORIZE IN HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 1 A MAXIMUM AD VALOREM TAX RATE OF

TEN (10¢) CENTS ON EACH \$100 OF TAXABLE VALUE OF PROPERTY AS PROVIDED UNDER HEALTH AND SAFETY CODE §775.0745.

WHEREAS, Notice of this Meeting of the Board of Emergency Services Commissioners, has been given in the manner and for the time required by law; and

WHEREAS, at an election held on the 2nd day of May, 2026, in the District there was submitted to the qualified voters an election ballot on the Proposition to authorize in Hidalgo County Emergency Services District No. 1 a maximum ad valorem tax rate of ten (10¢) cents on each \$100 of taxable value of property.

WHEREAS, in accordance with the canvassing information provided to the District by the Hidalgo County Elections Department on May 12, 2026, at the election, **60** votes were cast in favor of the Proposition, and **185** votes were cast against the Proposition; and

WHEREAS, the Proposition to authorize in Hidalgo County Emergency Services District No. 1 a maximum ad valorem tax rate of ten (10¢) cents on each \$100 of taxable value of property **did not** receive the **affirmative** vote of the majority votes cast at the election as provided by law,

THEREFORE, BE IT ORDERED, ADJUGED AND DECREED BY THE BOARD OF EMERGENCY SERVICES COMMISSIONERS OF HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 1, as follows:

Section 1: The matters and facts recited in the preamble of this Order are found and determined to be true and correct; the Proposition to authorize in Hidalgo County Emergency Services District No. 1 a maximum ad valorem tax rate of ten (10¢) cents on each \$100 of taxable value of property **failed** in a properly conducted election by the eligible voters of the District.
